# 9:05 Call to the Public – Jay – N/A

### 9:08 USFS updates – Amy and other USFS Reps

- Tami Connor accepted new position on National Priority Landscape (San Carlos), Amy Ormseth serving as acting while 120 detailer gets into place, and the position for 4FRI coordinator will be flown nationally
- Michelle Paduani returning to position
- Scott Rogers District Ranger on El Dorado R5 will be serving in 120 detail for 4FRI will work virtually for first few weeks starts Monday, May 1 title "Program Manager"
- FS in transition with Wildfire Crisis Strategy (WCS) and National Priority Landscapes Scott will help transition 4FRI into WCS realm, help determine what that means for reporting, etc.
- R3 is shifting supervision of 4FRI back to Coconino NF
- There is still a 4FRI Executive Board across the 4 forests
- See recording for additional discussion
- 4FRI Monitoring Coordinator position is stuck in Forest Service HR
  - Hiring is number one barrier across the Forest Service to accomplish WCS
  - o Hiring events are underway nationally to increase capacity
  - Should be a decision shortly on Monitoring Coordinator maybe 3-4 months until they are here

### 9:30 Prio-Opt "What is Optimization" discussion – Amy Waltz or Travis

- See recording for Amy Waltz's presentation
- Aaron Mayville direction from FS Chief is focused on treating the right 20-40% of acres, cannot fail, and the agency is using strategic planning tools how do these efforts dovetail?
  - Nigrelli doing a lot of the same things and the same time, so need to focus on our goals for
    optimizing this landscape and determining which tools can get us to our goals and monitor to
    determine how the treatments we are doing are changing the risk
    - The PriOpt workshop will help us determine what is the best tool for our needs and who can help us accomplish that for 4FRI, in a way that includes FS and SHG, and then determine how to implement it into treatment process
- Waltz multiple researchers focused on this, so of the suite of tools, which are the ones that can answer our questions, and which are the ones that the FS needs to focus on accomplish reporting
- Colavito need to ask model/ tool developers to articulate who is the audience for a given model, what geographic scale of reference it has, and what questions it can answer
- Waltz Failure can be ok, can help lead to adaptive management, can we be flexible to adapt and learn
- Nowicki Going back to letter of commitment, optimization is supposed to inform future sequencing to reduce overall risk of catastrophic fire to reduce risk to our highly valued assets, but that does not always mean treating the areas with the highest value attributes. We need to allow models to tell us where the work should be done to provide the greatest effect. How do we build the biggest boxes of restored fire regime with the most reasonable inputs as quickly as possible? Process of determining values more important than the model itself.
- Smith what does work group need from stakeholder group?
  - Waltz values assessment is broad stakeholder engagement, especially important to include industry and operational perspectives. Similar effort occurring on Burnt Corral, discussion on how we might leverage efforts.
  - Woolley we don't want to recreate learning over and over, so it will be important to participate in learning as we move forward

o Waltz – want to include fire professionals, and be aware of fire season

## **10:00** Review SDR proposal for external support – Melanie or Jay

- Forest Service has budgeted for the estimated costs for SDR, can start in FY24
- Might be best to have fiscal sponsor come from county, NAU's overhead rate is 25.5%
- Good to think about more facilitation needs than less
- Agreement to move forward with SDR facilitation for 4FRI according to proposed scope/ budget
- Next steps:
  - Jay to determine if County can be fiscal sponsor; Travis will also ask TNC
  - Jay and Melanie to confirm financial commitments
- As soon as there is funding in place with some entity, SDR can start
- There will need to be two separate contracts/ agreements, one for FS and one for SHGs via the fiscal sponsor

- Road infrastructure discussion/ subgroup of industry work group potential for June 2023
- TNC recent papers relevant to 4FRI and restoration, post-fire regen, carbon could be June or August 2023

# 10:35 Industry Updates – All

- Campbell Global TNC SPAs ongoing; road/ ground conditions improving; doug fir and hemlock species are a 1/3 to ½ their price for lumber, which impacts 4FRI and ponderosa thinning negatively; Parks West SPA has two contractors (Dakota logging subcontract to Hammer logging); also doing meadow restoration/ wildlife corridor creation by I-40 and removing some ponderosa overgrowth for pile burning; TSI post-treatment areas for burning
- RFOR Walker Hill ongoing, and subcontractor on Camp Navajo, still wet in spots making things challenging; planers going in on mill; Elk Clark getting started, discussion ongoing
- Canyon Creek drying out on most sales, just did Miligan Valley Stewardship project; lot of operations
  were shut down through winter but kept crews busy with PJ work; actively investing in new equipment
  to double logging capacity; moving about 40 loads a day between logging and biomass but hope to push
  to 50-60 in coming months
- Novo week and a half of inventory; current challenge is running at full load just on juniper but in better place than in winter, and hopeful about getting some pine soon; TriStar is having difficulties; NovoStar plans to start this week at about half capacity and truck fleet down to 1/3 of what it used to be, so this is a major shift and Canyon Creek is filling some capacity gaps; Novo bought remaining sawmill equipment from Vaughan Group to help them avoid foreclosure; these capacity issues will impact work getting done on CC Cragin due to the haul distance as it will be a priority for limited trucks to go somewhere close; frustration that Novo was not qualified for haul assistance program because of concern about WIPA grant and stewardship agreement overlap as the agreement barely covered increased costs of inflation (Aaron asked for a note from Brad with the details on this); offered to assist with SDR agreement if appropriate
- Suarez working in Walker Hill demo and worked decently through winter and have about half skidded;
   finished plowing 300 road for Cragin; hoping to get 100 loads decked on Roosevelt; hope to be into
   Baker in 7 weeks
- Coconino County several SHG groups attended R3 FS-hosted industry roundtable, not a lot of actionable outcomes from the meeting; there was some discussion about why the roundtable as not applicable to 4FRI, likely because 4FRI has already had a lot of the discussions
- DFFM five new GNA agreements coming for about 32K acres on Coconino and Tonto, not including first GNA with Kaibab that is requesting help with arch services; 2023 task orders looking at 7 for hand

thinning, mastication, and timber removal for 12K acres; working with Mogollon Rim district with plan and funding in place to start working on road repairs to Cragin

  - Working within subgroups to get 2023 field season running ground plots and springs monitoring in first phase 4FRI
  - Also planning for expansion into Rim Country, capacity limited
  - Working on FY24 budget proposal for review
- Comprehensive Implementation WG Hannah Griscom
  - Several projects planned for summer with partners AZ Elk Society and FONAF and GCT in CC Cragin watershed, as well as Lake Mary watershed with GCT leading and help from Coconino in planning and implementing those projects this summer
  - New hydrologist on Coconino working on out year planning for watershed restoration implementation in collaboration with CIWG
  - Letter submitted on March 28, 2023 requesting increased capacity for channel/ stream
    restoration and engagement with forest to help with projects, have not received any formal
    engagement from the letter yet, but hoping it is in review and consideration with respect to
    hiring plans in FS
  - Some field trips planned to look at more specific planning (May 3 Lake Mary; May 22 Mogollon Rim – let Hannah know if you want to join)
- Treatment Prioritization and Optimization WG Amy Waltz/ Travis Woolley
  - See earlier presentation
